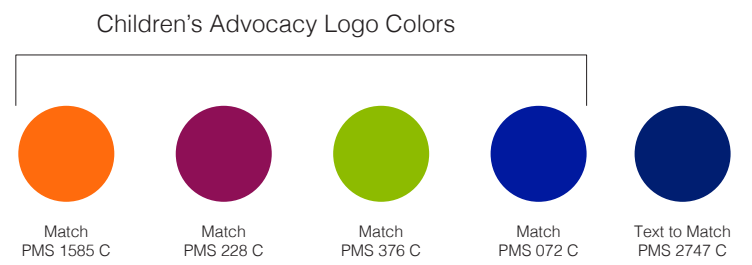


Slighted rounded safety corners
